Cyber Coverage Descriptions & Availability Summary

› Website Publishing Liability

Provides coverage for content posted to your website that results in infringement of copyright, trademark, trade dress or service mark, or defamation or violation of a person's right to privacy due to error, misstatement or misleading statements by you.

› Security Breach Liability

Provides coverage for neglect, breach of duty or omission by you that results in personal information in softcopy or hardcopy form that is acquired by those unauthorized to have it or published by those who are authorized to have it. Coverage is also provided for release of malicious code from your computer system.

› Replacement or Restoration of Data

Provides coverage for the costs to replace or restore data or computer programs that are damaged or destroyed as a direct result of an e-commerce incident.

› Regulatory Proceedings Expense Sub-Limit

Provides coverage for the payment of fines, penalties and defense expenses as a result of a data breach.

› Public Relations Expense

Provides coverage for fees assessed by a public relations firm to rebuild your reputation after a computer breach or the release of virus, malicious code or denial of service attack.

› Security Breach Expense

Provides coverage for various expenses associated with the mitigation of a security breach.
